Membership - Automobile and Motorcycle

A large number of track days have been allocated for Motorsport Club Members of which the member under this agreement can use 30 days. These days will include days of the week including some afternoons and evenings. For various reasons some of these days may change but the combination of available weekend days, weekdays and evenings will not. The first two years of dues are payable with this application with the following years to be charged upon your accepted renewal. After any term has expired GrandSport Speedway may adjust the fees at their discretion. Memberships are non-transferable and non-refundable once purchased. All memberships include a 2-day Racing Adventure in your own car provided by Racing Adventures Driving School. This school is mandatory to all members unless the member can demonstrate prior track experience that shows track driving competence, an understanding of racetrack protocols and procedures. The school will not count towards your track day allocation. If you have experience and do not require the school you can give one day of it to a friend!

After payment of your membership there are no daily or monthly fees for use of the track during the term of your agreement.

Memberships

Limited Pre-Phase 2 Construction Promotional Price. \$3000 per year + 8.25% Tax (247.50) = \$3,247.50

At the time of original purchase additional years may be purchased at an investment of \$2500 per year + tax. Thereafter the member will be subject to the membership price offer at the time of renewal.

Ten Year membership - \$15,000 + 8.25% Tax (\$1237.50) = \$16,237.50

Lifetime Membership - \$25,000. + 8.25% Tax (\$2062.50) = \$27,062.50 Membership for the lifetime of the racetrack.

All memberships are of the non-equity type, non-voting type.

Membership Options

Options are in menu style and are for members only.

Additional Track Days

After your allocation of track days is used members may purchase additional track days at the rate of \$150 per day. These are purchased in blocks of five days at a time. All track days are not transferable.

Instructional Services

GrandSport Speedway has on site professional driver coaches to assist you in all your driver coaching needs to all levels of the sport. These services will be charged out at \$250-\$500 per day depending on the professional you request.

Family Usage

Family membership includes only family members living in one residence. After you have purchased your base fee other family members may join for \$1750 per family member per year.

Corporate /Business Memberships

Memberships are available by request. Please give us a call and we can discuss your specific needs.

Outside Trailer Storage

Outside trailer storage is available at \$75 per month. (GrandSport Speedway will be in no way responsible for damage or theft of vehicles or equipment stored on site. We recommend members purchase insurance for all of their property)

General Indoor Car Storage

These are limited indoor storage areas for member cars at \$100 per month. Storage only, there will be no working on cars in this area. (GrandSport Speedway will be in no way responsible for damage or theft of vehicles or equipment stored on site. We recommend members purchase insurance for all of their property)

Private Garages

Private garages 12'X24' are available for \$300 per month and 24'X22' for \$500 per month. The garage rentals are based on one year leases. If you are interested in a garage please call and place your first and last month rent down and you will be placed on the priority list. Members will be offered the garages as they are built first come first serve basis. Rates may increase at any time. (GrandSport Speedway will be in no way responsible for damage or theft of vehicles or equipment stored on site. We recommend members purchase insurance for all of their property)

Helmet Rental

Helmet rentals are available for you and their guests at \$10 per day

Guest Passes

Member guest passes are available for the cost of \$200 per day. Each member can purchase 4 passes per month and only bring the same person as a guest 4 times per year. The guest must qualify to drive on the track.

Additional services will be offered as they become available.

**GRANDSPORT SPEEDWAY MOTORSPORTS CLUB – DBA of Legend Motors Inc.
MEMBER WAIVER AND RELEASE**

The Undersigned (the "member") has applied for enrollment privileges as a member driver at GRANDSPORT SPEEDWAY a DBA of Legend Motors Inc. a Nevada corporation (collectively, "the track"), and in consideration of the services to be rendered by "the track", the "member" hereby agrees as follows:

1. The member acknowledges that they have voluntarily enrolled and the services being offered by the track involve the operation of various types of motor vehicles at all rates of speed including high rates of speed, which may be extremely hazardous and may expose the member to risk, injury or even death to their person or property, or risk of injury to another person or the property of another person or people. The risk of injury to the member or his property, or to another person or his property, is inherent in participating in the services or activities being offered by the track and injuries could arise from numerous causes, including but not limited to, an act of the member, the act of another person, (negligent or intentional) a mechanical malfunction of any type or failure, or the physical properties of the race track road course or the other facilities of the track. The member acknowledges that they are fully aware that there is risk inherent in participating at the track and because the member desires to be at the track, the member is willing to assume all such risks. The member further agrees to utilize any and all safety equipment provided or made available to him while at the track premises and any area made by available by the track, but the member nevertheless recognizes that whether or not such safety equipment, if utilized, fails to operate shall not affect his full assumption of all risk of injury or the Waiver and Release provisions contained in this Waiver and Release.

2. In addition to the non-refundable membership fees paid to attend the track, as consideration for participation at the track, the member agrees that:

a) The member, on behalf of themselves, their heirs, successors and assignees, hereby assumes all risks of injury or damages to his person or property, including but not limited to the death of the member while participating at the track, and all risks of injury or damages to the person or property of another, whether caused by intentional or negligent acts or otherwise;

b) The member on behalf of themselves, their heirs, successors and assigns, hereby releases and forever discharges the track, its sponsors, and any sponsors which may be added in the future, and the representatives, agents, servants, employees, officers, directors, other members and shareholders of the track, the track Sponsors, of and from any and all claims, demands, actions, and causes of action of any kind whatsoever, whether known or unknown, disclosed or undisclosed, mature or unmatured, which arise out of or are in any way connected with the members participation at the track; whether caused by the negligence of the track, the track sponsors or otherwise.

c) There is a risk that is subsequent to the execution of this release that the member will incur or suffer a violation of personal rights or other loss or damage, or any of these, which are in some way caused or connected with at the track, but which are unknown and unanticipated at the time this Release is signed. The member hereby expressly assumes the above-mentioned risk, and this Release applies to all unknown or unanticipated actions, and the Member hereby waives all rights.

d) The member, for themselves, their heirs and assignees, agrees to defend, indemnify and hold harmless the track, The track sponsors and the representatives, agents, servants, employees, officers, directors, members and shareholders of the track, from and against any claim, demand, suit, judgment, cost or fees, or other liabilities, including attorney fees, which arise out of or are in any way connected with the member's participation at the track; whether caused by the negligence of the track, the track Sponsors or otherwise;

e) For purposes of this Waiver and Release, any plural term includes the singular, and any singular term includes the plural, and the masculine gender shall be deemed to include the feminine, in each case where the context so indicates;

f) In the event that any one or more provisions contained in this Waiver and Release should, for any reason, be held to be unenforceable in any respect, such unenforceability shall not affect any other provision of this Waiver and Release, and this Waiver and release shall be construed as if such unenforceability had not been contained herein;

g) The undersigned member, in executing this Waiver and Release does not rely upon any inducements, promises, or representation other than those contained in this Waiver and Release. This Waiver and Release is freely and voluntarily executed by the "Member" and the member has had to right and opportunity to discuss and gain legal advice in relation to this waiver to its content.

h) If the member uses his own vehicle, or a vehicle he provides, or is provided by another party the member warrants that the vehicle is suitable for the purposes used at the track and agrees that the track is not responsible for any loss or damage to his vehicle;

i) The member agrees that they will follow and withhold the posted rules of the track at all times. Whenever notice is required to be given to member, it may be delivered either personally or by first-class mail, email, fax or other written communication, addressed to member at the address of member appearing on the application and/or file or at the address given by member to GrandSport Speedway for the purpose of notice. If no current address appears on GrandSport Speedway's books and no other has been given, notice shall be deemed to have been given and received.

j) *Force Majeure*. If during the term of this Agreement there should arise or occur any event or circumstance beyond the reasonable control of GrandSport Speedway, including without limiting the generality of the foregoing, the action of government, flood, fire, strike, lock-out or other labor unrest, riot, civil unrest, terrorism, war (whether declared or undeclared), or an act of God, which prevents, restricts or delays GrandSport Speedway from duly performing any of its obligations under this Agreement, then during the period that such event or circumstance, or the effect thereof, continues, performance by GrandSport Speedway of such obligation will be suspended and excused to the extent that it is so prevented, restricted or delayed.

k) The member agrees that the track, its personnel shall have the right at any time, which they in their sole discretion may see fit, to cancel their membership at the track, either before, after, or during any particular term or stage, for any reason whatsoever, and without giving cause. The member will then either be refunded for their unused portion of their membership or forfeit all and any payments made to the track for the remainder of the term of the agreement at the discretion of the track.

l) This Release is to be governed and interpreted by the laws of the State of Nevada. All disputes arising out of or in any way connected with this Waiver and Release or its subject matter and all disputes arising out of or in any way connected with the member's participation in the track shall be resolved by the laws of Nevada.

Credit card information

The members signature on this document will suffice as confirmation to bind any credit card payment I have made towards any of GrandSport Speedway products or services at anytime or to compensate GrandSport Speedway for any damage(s) the member may have caused or damages caused by someone the member is responsible for. By providing GrandSport Speedway my credit card number I understand that my financial responsibility surpasses my credit card agreements with my credit card provider and I have entered into binding a financial agreement in which my credit card is the instrument of payment. If I change my credit card information at anytime or cancel my card I will contact GrandSport Speedway immediately and provide the updated information. If I fail to provide credit card updates or provide an alternate usable financial instrument I understand that I may be committing a fraudulent act and I am responsible for the actions that may follow.

Car Eligibility

GrandSport Speedway reserves the right to inspect and perhaps limit the use of any car on the track or on the premises at anytime without reason or explanation.

I have had the opportunity to seek independent council in relation to my understanding of this document and agree to abide by all GrandSport Speedway, rules, and regulations.
